- c. establishing, operating or managing companies, legal entities or similar bodies as referred to in Article 2, first paragraph, part b, of the General National Ordinance on National Taxes or organizing the input necessary for the establishment, operation and management thereof;
- d. the purchase or sale of shares in, or the entire or partial purchase or sale or takeover of companies, companies, legal entities or similar bodies as referred to in Article 2, first paragraph, part b, of the General National Ordinance on National Taxes;
- e. acting as an external registered accountant or external accountant administration consultant, providing forensic accountancy services, or similar activities.
